

ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the City of Lake City – John St. Watermain Replacement will be received at the office of the City of Lake City Hall, until 11:00 am local time on August 6, 2018, at which time the Bids received will be publicly opened and read. The Project consists of replacement of approximately 630 linear feet of existing 4" watermain. This includes replacing 630 linear feet of 4" watermain with 6", along John Street, from Main Street to Houghton Street in the City of Lake City. There is also watermain service replacement, fire hydrant replacement, storm sewer repair, crush and shape existing asphalt, restoration of all disturbed areas, and paving.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis as indicated in the Bid Form.

Builder's Exchanges are authorized to share the contract documents with other exchanges.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above. Bidding Documents are available on compact disc (as portable document format (PDF) files) for a non-refundable charge of \$30 [thirty], ~~including~~ which includes standard shipping ~~via overnight express service~~. Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$100 [one hundred] per set, payable to "Gosling Czubak Engineering Sciences", which includes standard shipping plus an additional shipping charge of \$36 (thirty-six) for overnight express service if requested. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A pre-bid conference will be held at 11:00 am local time on July 30th, 2018 at the City of Lake City Hall, 115 W John St., Lake City, MI 49651-0909. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
