ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Village of Elk Rapids Water and Sewer Improvements Various Locations Project will be received, by the Village of Elk Rapids, at the office of the Village of Elk Rapids, 315 Bridge Street, Elk Rapids, Michigan until 10:00 am local time on July 26, 2024 at which time the Bids received will be publicly opened and read. The Project consists of;

- A. Water Improvements: 152 LF of 6-inch PVC watermain for connection to 6-inch hydrant assembly's, 2,761 LF of 8-inch PVC watermain, 1,412 LF of 8-inch HDPE watermain, hydrants, gate valves, water services, asphalt / concrete / gravel remove and replace, and restoration.
- B. Sewer Improvements: 1,273 LF of 8" PVC sanitary sewer, 986 LF of 10" PVC sanitary sewer, 63 LF of 4-inch PVC forcemain, 4-foot diameter sanitary sewer manholes, sanitary sewer services, asphalt / concrete / gravel remove and replace, and restoration.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with alternate bid items as indicated on the Bid Form.

A Mandatory Pre-bid meeting will be held at 10:00 am on July 12, 2024 at the office of the Village of Elk Rapids, 315 Bridge Street, Elk Rapids, Michigan.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above. Bidding Documents are available for download (as portable document format (PDF) files) for a non-refundable charge of \$0.00 zero dollars. Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$250.00 two hundred fifty dollars per set, payable to "Gosling Czubak", which includes shipping. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bid security shall be furnished in accordance with the Instructions to Bidders.
